Re: Request for information under the Freedom of Information Act 2000

Thank you for your request under the Freedom of Information Act 2000, which was received by NHS South Devon and Torbay Clinical Commissioning Group ("the CCG") on 2 September 2016.

I can confirm that the CCG holds the requested information, and this is released to you.

I should be grateful to be shown the broad costings and totals of - Cost per bed per day: Community Hospital versus District General Hospital of the hospitals in the SD&T CCG ambit. I am sure they will be available. I realise there will be a lot of headings eg

- Capital charges as at Newton Abbot
- Property maintenance
- Staff of the many sorts, and about 60% of the total.
- Back-up services pathology etc
- Radiology often involving very expensive apparatus.
- to name some

It might be said that the CCG will have no access to Torbay hospital costs, but the CCG quotes them as being £250 pbpd cf £275 for CH and it would not do that unless there was a factual basis.

Incidentally, the DoH has an approximate figure of £400 for the DGH pbpd

Please add 'Care at Home': cost per person per day. I have asked for this informally before but not got an answer. I realise there will be a wide range but an average will be known, and the extremes - 'help with morning shower' up to

doubly incontinent patient with several pathologies. The average over 100 patients, plus the low and the high values.

The CCG does not initially hold information at this level. This level of data is held by the provider themselves. However on this occasion, the CCG has created a joint response with Torbay and South Devon NHS Foundation Trust.

'Care at Home' cost per person per day

In regard to the term 'Care at Home' we have assumed this to be Domiciliary Care. By definition this excludes direct payments, as we cannot with any accuracy say how each individual utilise their funds, this therefore excludes placements within nursing / residential homes.

We have split the analysis between CHC (which covers Torbay and South Devon) and adult social care (ASC) (just covers Torbay). We do not have direct access to South Devon ASC detail to incorporate this. A separate request for information would need to go to Devon County Council for that element.

The figures below cover all client type groups 18 years old and above, and the Torbay ASC figures exclude any supported living provision.


